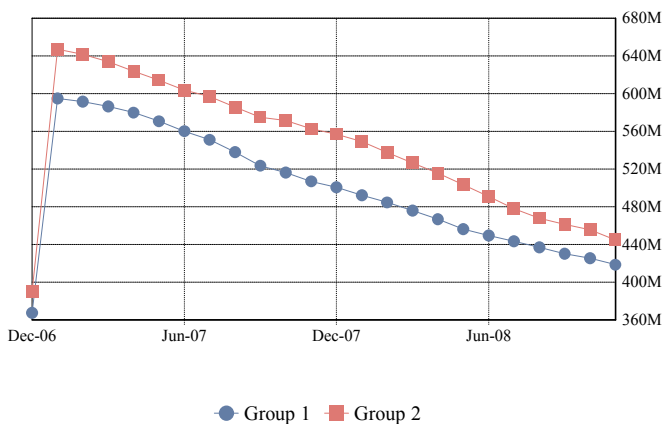

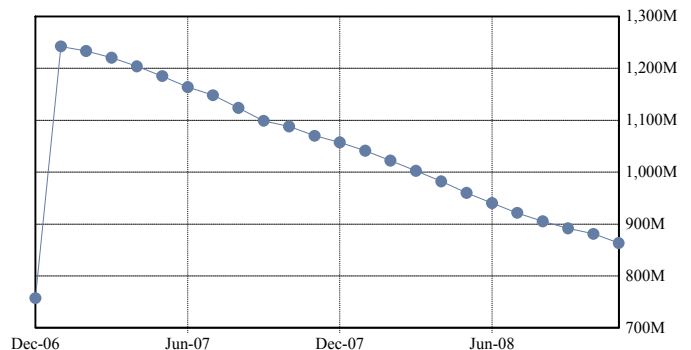

Current Principal Balance by Groups



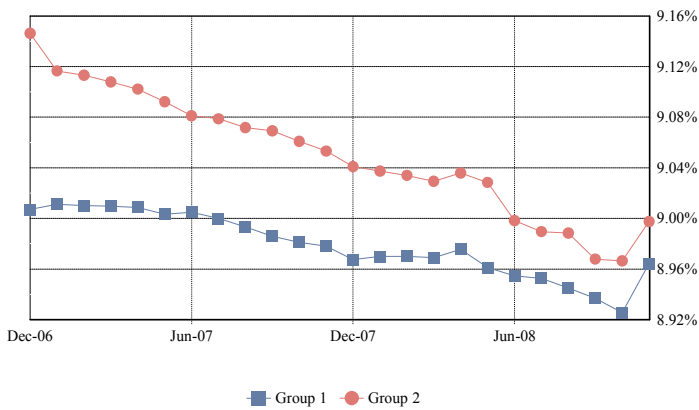

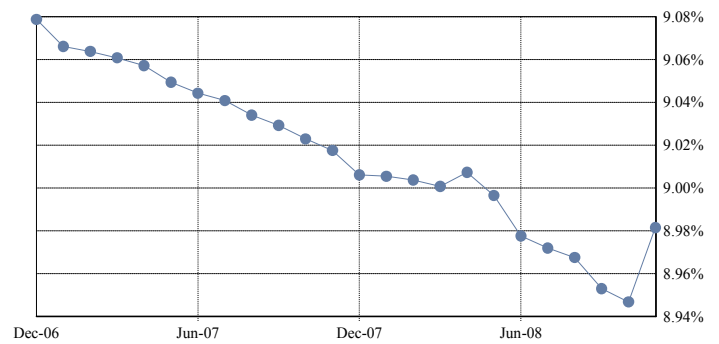

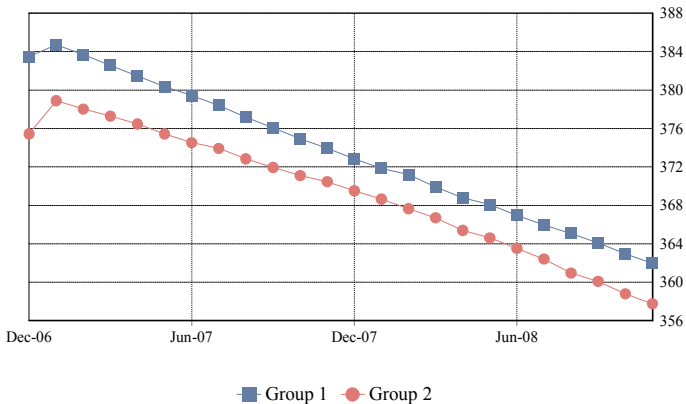
Weighted Average Coupon by Groups



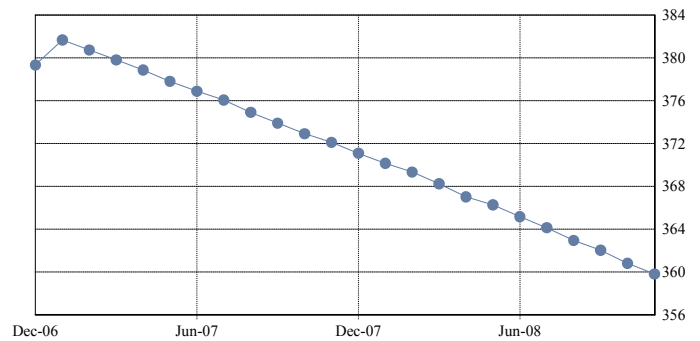
Total Weighted Average Coupon

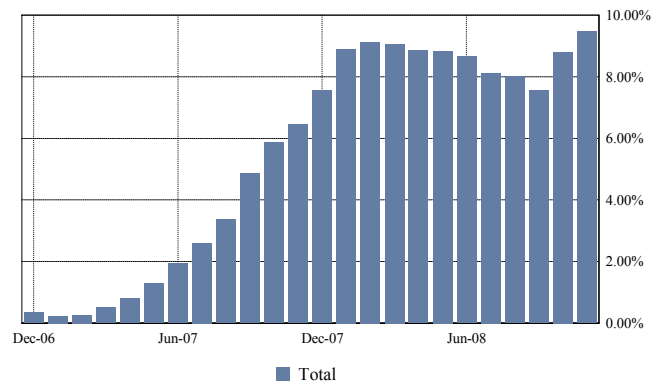

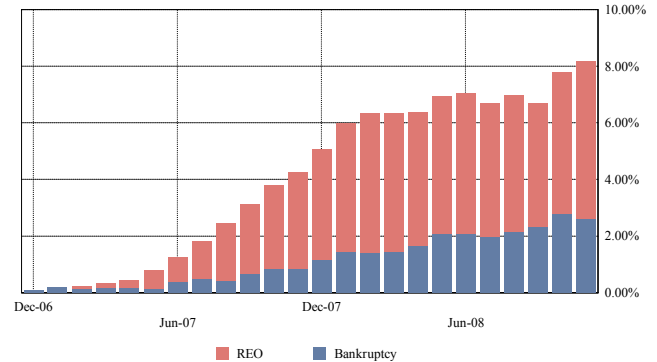

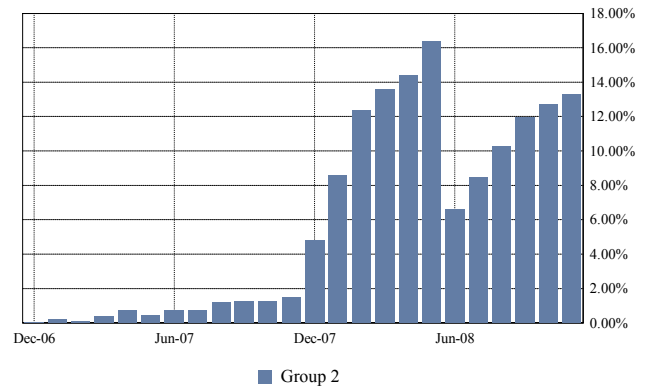

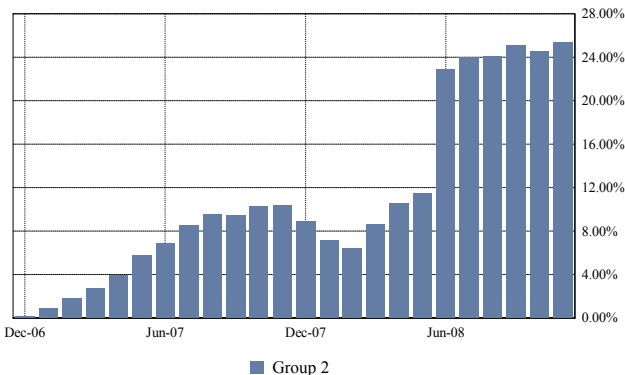

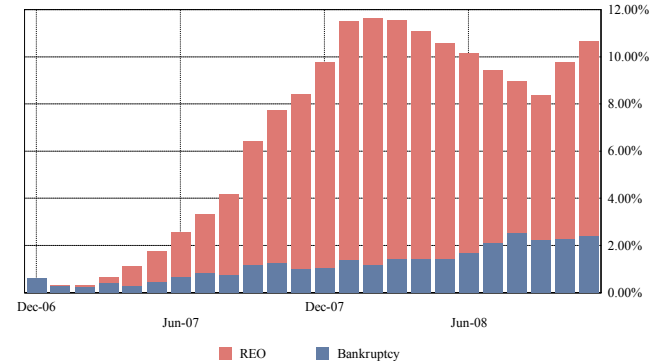

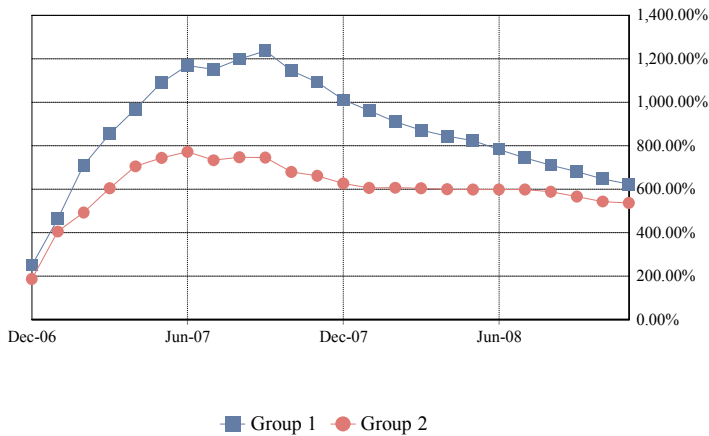
CPR Avg since Cut-Off by Groups



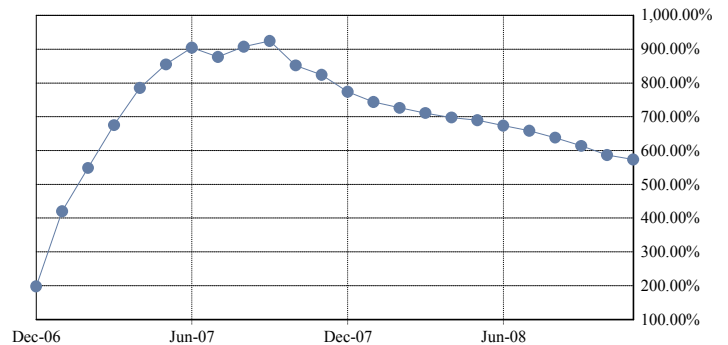

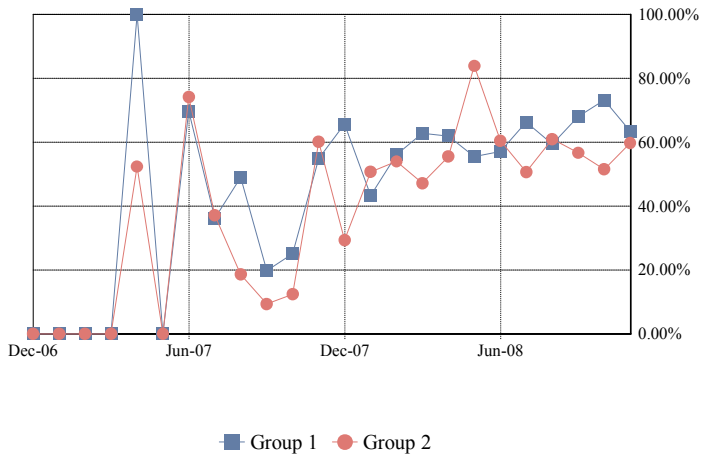

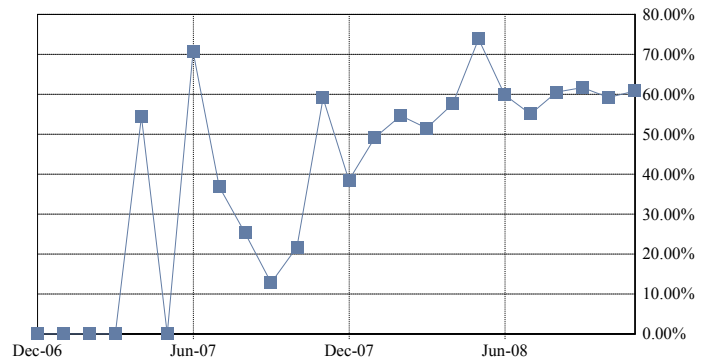

Collateral Loss Severity Approximation by Groups



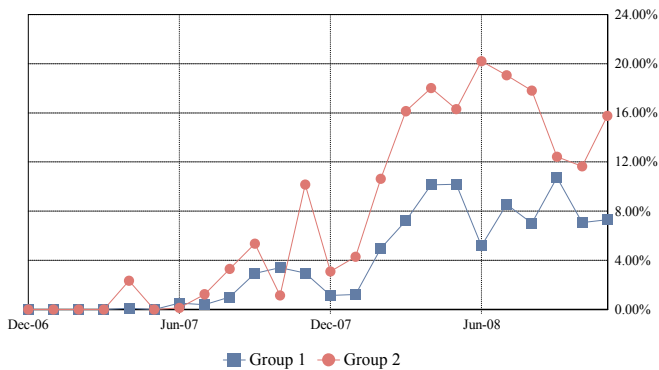
