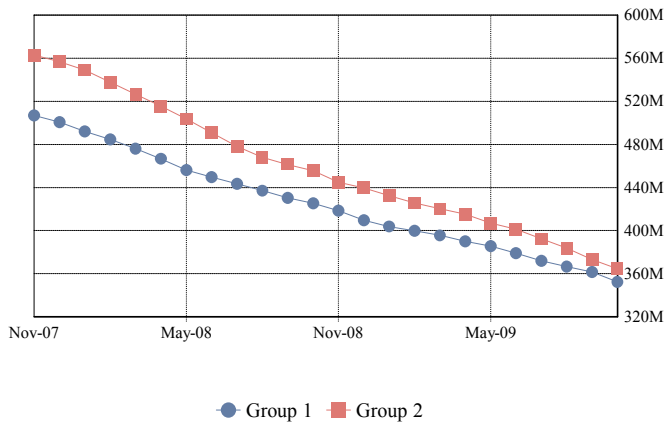

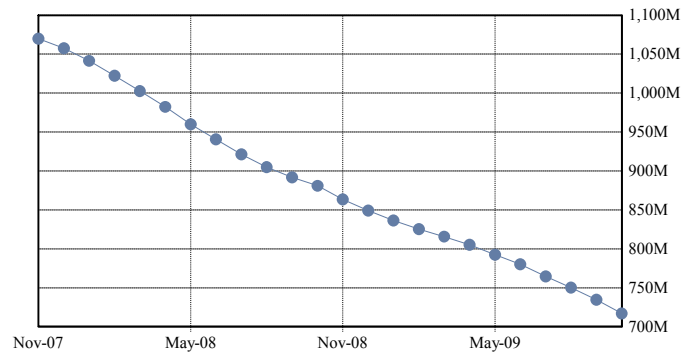

**Current Principal Balance by Groups**



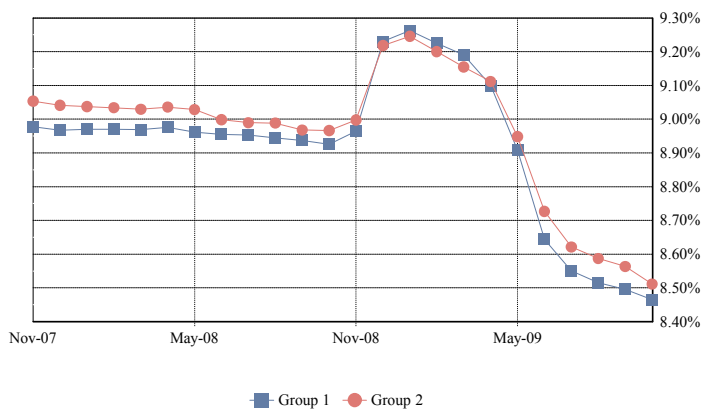

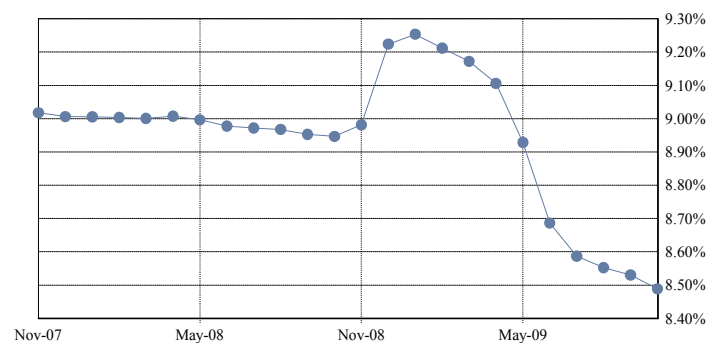

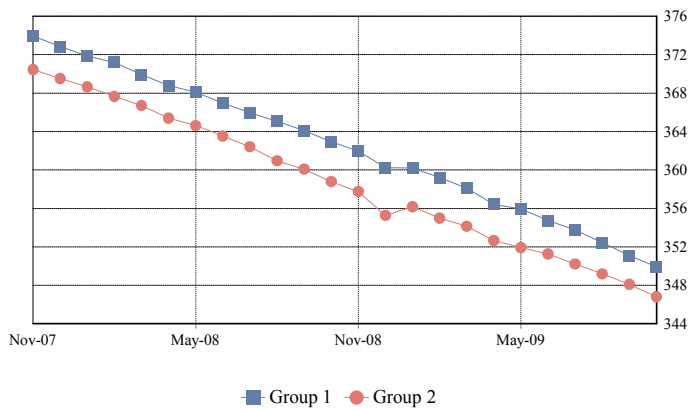
**Weighted Average Coupon by Groups**



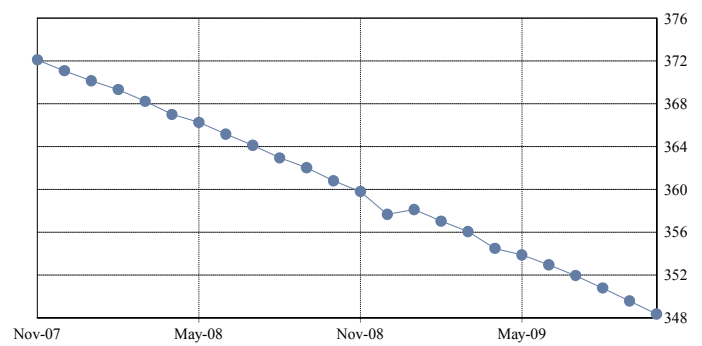
**Total Weighted Average Coupon**

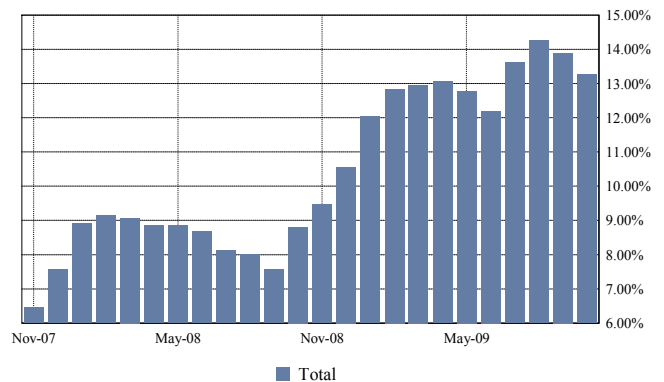

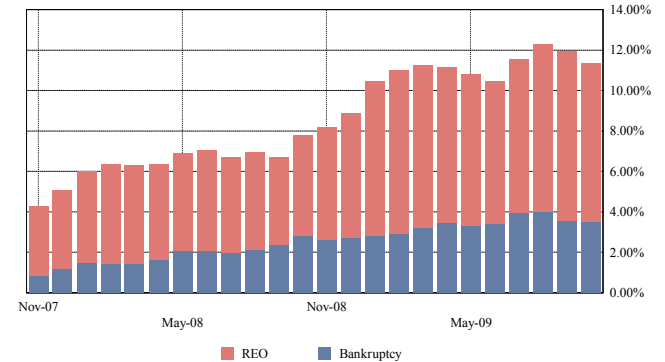

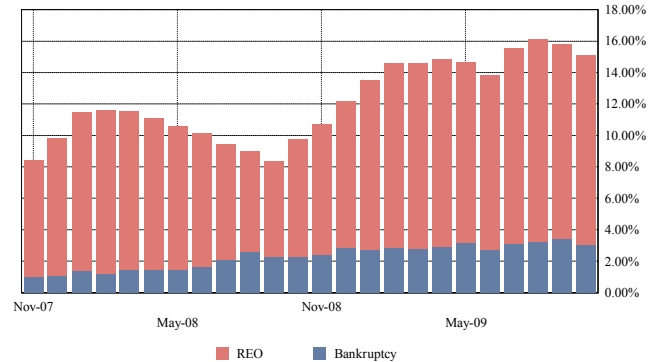

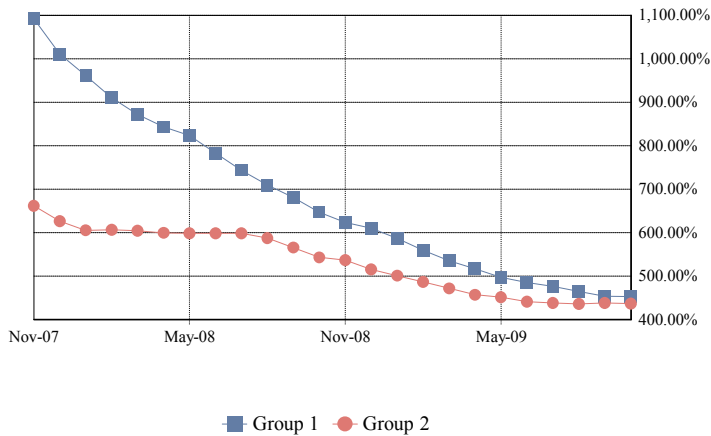
CPR Avg since Cut-Off by Groups



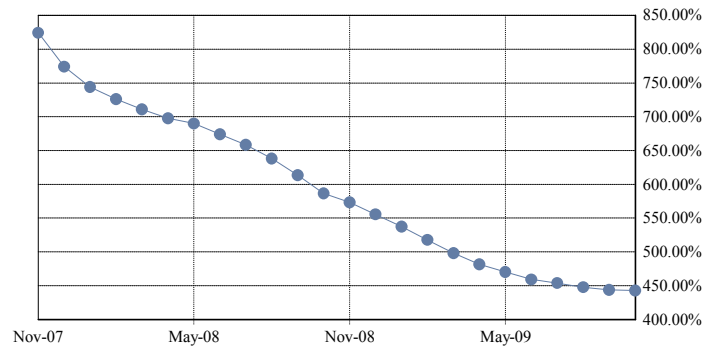

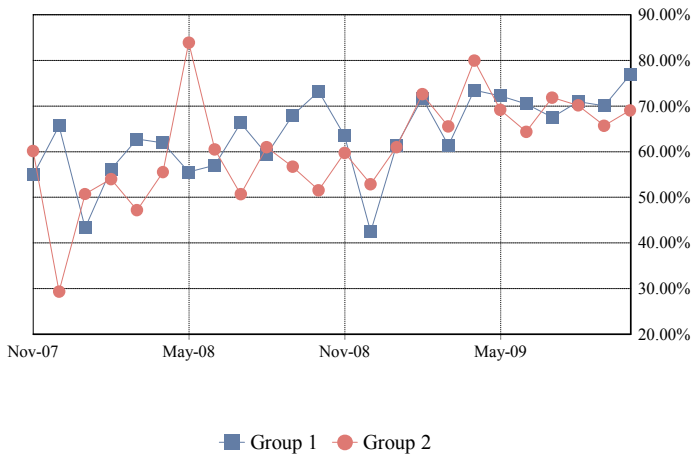

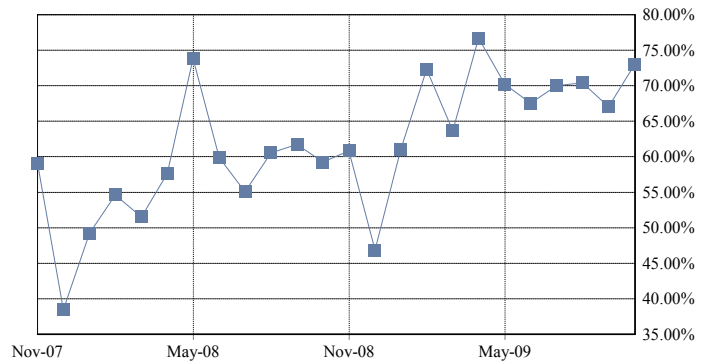

Collateral Loss Severity Approximation by Groups



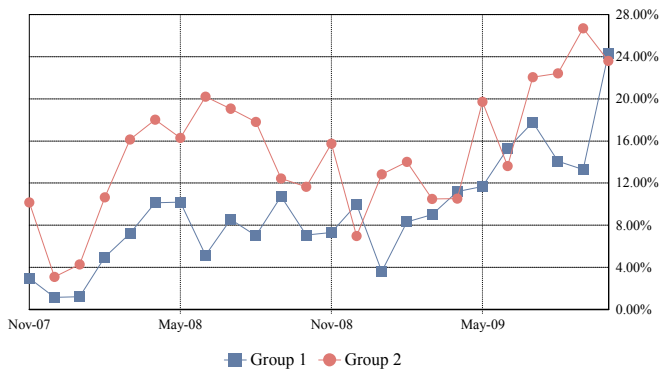
